"Work Change" means a deletion from the Work, or an addition to or revision of the Work which is within the general scope of the Contract;

"Work Program and Schedule" has the meaning set out in Schedule 4 [Work Program and Schedule];

"Work Site" means the location where the constructed Work is to be finally or permanently located or installed;

"Worker" has the meaning set out in Appendix 6-2 [General Technical Specifications];

"Worker-Adjustable" has the meaning set out in Appendix 6-2 [General Technical Specifications];

"Worker Accommodation Area" has the meaning set out in Schedule 2 [Design and Construction Protocols];

"Worker Accommodation Facility" has the meaning set out in Schedule 2 [Design and Construction Protocols];

"Worker Accommodation Operator" has the meaning set out in Schedule 2 [Design and Construction Protocols];

"WorkSafe BC" has the meaning set out in Schedule 10 [Safety];

"WPP" has the meaning set out in Schedule 10 [Safety]; and

"ZVPU Probe" has the meaning set out in Appendix 6-4 [Governor System Specifications].

Any words or phrases defined elsewhere in the Contract will have the particular meaning assigned to such words or phrases.

2 INTERPRETATION


Except as expressly set out otherwise in the Contract Documents or as the context otherwise requires, the following will apply to the interpretation of the Contract:

- the Contract Documents are complementary and will be read and interpreted together and what is required by any one Contract Document will be deemed to be required by all Contract Documents;
- (b) where there is a reference in any Contract Document to:
 - (i) "Contractor", it will be read as a reference to "the Supplier"; and
 - (ii) "Issued for Construction" or "IFC", it will be read as a reference to "Issued for Installation" or "IFI";
- (c) headings are for convenience and reference only and will not affect the interpretation of the Contract;
- (d) all dollar figures will mean Canadian dollars;
- (e) any notice or communication required or permitted to be given under the Contract will be in writing;
- (f) words importing the singular include the plural, and vice versa;
- (g) words importing gender include all genders;
- (h) where a reference is made to a "day", "week", "month" or "year", the reference is to the calendar period;
- (i) where the date for any delivery or response falls on a Saturday, Sunday or statutory holiday observed in British Columbia, the date for such delivery or response will be extended to the next following day which is not a Saturday, Sunday or statutory holiday observed in British Columbia;
- (j) in the calculation of time, the first day will be excluded and the last day will be included;
- (k) the words in the Contract Documents will bear their natural or defined meaning;
- (I) the word "including" is deemed to be followed by "without limitation";
- (m) any reference to a statute will include such statute and its corresponding regulations, together with all amendments made to such statute and regulations and in force from time to time, and any statute or regulation that may be passed which has the effect of amending, supplementing or superseding the statute referred to or such statute's corresponding regulations; and
- (n) the parties confirm that they each have obtained independent legal advice, or elected not to obtain such advice, and accordingly agree that any rule of construction to the effect that any ambiguity is to be resolved against the drafting party will not be applicable in the interpretation of the Contract.

3 PRIORITY OF CONTRACT DOCUMENTS

If there is any inconsistency or conflict between provisions of the Contract Documents, then:

- (a) the order of priority between the Contract Documents, from highest to lowest with the Agreement having the highest priority, is as follows:
 - (i) the Agreement;
 - (ii) Schedule 1 [Definitions and Interpretation];
 - (iii) Schedule 2 [Design and Construction Protocols], excluding
 - (iv) Schedule 6 [Specifications and Drawings];
 - (v) remaining Schedules; and
 - (vi) subject to Section 4 of this Schedule 1 [Definitions and Interpretation],
- (b) except for schedule; (b) except for schedule;
- (c) drawings of a larger scale have priority over drawings of a smaller scale;
- (d) figured dimensions on a drawing will have priority over scaled measurements on the same drawing; and
- (e) documents of a later date will have priority over the same or similar type of document of an earlier date.
