## Site C: Indigenous Traditional Use Fund

BC Hydro has established the Indigenous Traditional Use Fund (ITUF) to mitigate the impacts of the Site C project, and help preserve land and resources for traditional use. Thirteen Indigenous Nations impacted by Site C are eligible to access \$13 million<sup>1</sup> in funding and participate in the process for determining how these funds are used in partnership with BC Hydro.

- O Mitigate the impacts of the Site C project on the current use of land and resources for traditional purposes
- O Address traditional use concerns not covered by existing Site C mitigation and monitoring programs and conditions
- Build capacity and foster collaboration with the 13 Indigenous Nations impacted by Site C through program development, governance, and project implementation
- Create meaningful space for traditional ecological knowledge and western science in the implementation of programs and projects
- O Develop projects aligned with shared values that result in trusted data, accessible information, and meaningful outcomes

## **Quick facts:**

- O \$13M Fund<sup>1</sup>
- O ITUF program area covers 50,000km<sup>2</sup>
- The 13 Indigenous Nations identified in the Environmental Assessment Certificate and Federal Decision Statement are eligible for ITUF funding
- The details and approach to ITUF were collaboratively developed by the Site C Environmental Forum and the participating Indigenous Nations
- O Year 1: Each Indigenous Nation is eligible for \$50K for project implementation
- Years 2-4: Each Indigenous Nation is eligible for \$150,000/year for project implementation
- O \$1.5 million in funding has been allocated to Multi-Nation projects
