**RE: Site C Clean Energy Project – Heritage Resources Management Plan 2018 Annual Report (for the period January 1 to December 31, 2018)**

I am writing to provide you with an annual update on BC Hydro's Heritage Resources Management Plan (HRMP) for 2018. This update is being submitted in accordance with Condition 15.6 of the Site C Project's Decision Statement, issued to BC Hydro on October 14, 2014 (and revised on November 14, 2014), as well as with reporting required outlined in the HRMP.

Per Condition 15.6 of the Decision Statement:

The Proponent shall implement the plan and provide to the Agency an analysis and summary of the implementation of the [Heritage Resources Management Plan], as well as any amendments made to the plan in response to the results, on an annual basis during construction and for the first five years of operation, unless otherwise indicated.

This plan also provides an update on Condition 62 of the Environmental Assessment Certificate, which requires that BC Hydro "protect and preserve heritage resources by implementing measures as detailed in a Heritage Resources Management Plan." In addition, per Condition 9 of the HRMP, BC Hydro has committed to preparing and submitting an annual report to the BC Archaeology Branch, the Environmental Assessment Office (EAO), Indigenous groups and the Métis Nation British Columbia.

The HRMP was developed by BC Hydro, in consultation with Reservoir Area Aboriginal groups and the Métis Nation British Columbia, to avoid, minimize or manage impacts to local archaeological and heritage resources. The draft HRMP was submitted to the Archaeology Branch of FLNR, Indigenous groups, and Métis Nation British Columbia on October 17, 2014. The final HRMP was submitted to EAO, the Archaeology Branch of the Ministry of Forests, Lands, Natural Resource Operations and Rural Development, Indigenous groups and Métis Nation British Columbia on June 5, 2015.

In response to a direction from the British Columbia Environmental Assessment Office, the HRMP was also updated and submitted to regulators, the Archaeology Branch and Indigenous groups on November 19, 2018. These revisions include:

- providing definitions of "confirmed heritage resources" and "reported but unconfirmed heritage resources"

- setting out roles and responsibilities for implementation of the plan
- providing a process for reporting, identifying and inspecting location of unconfirmed heritage resources
- describing a process confirming the protection status of archaeological and historical sites, including burials
- clarifying the circumstances in which avoidance will be considered as an option for mitigating impacts to heritage resources, and providing further description of management options for burial sites protected under the Heritage Conservation Act, and
- further defining the heritage monitoring and follow-up program.

### **Heritage Resource Work in 2018**

The heritage resources program for the Site C Project is a multi-year integrated study comprising assessments of palaeontological, archaeological and historical resources.

The palaeontological resources investigation and mitigation program entered its 9<sup>th</sup> year in 2018, and investigations have been completed at multiple locations across the project activity zone. As the palaeontology program is nearing completion, in 2018, no palaeontological investigations or mitigation took place. The two remaining locations requiring mitigation are scheduled for 2019. Two palaeontological chance find call-outs to site were conducted during the course of construction on the Project in 2018.

The archaeological and historical program also entered its 9th year in 2018. In 2018, archaeological field studies were principally focused on South Bank reservoir clearing access roads, and the Highway 29 realignment corridor. Our 2018 field season resulted in the following work:

- 35 new archaeological sites recorded;
- 32 previously recorded sites revisited;
- 26 sites with systematic data recovery completed;
- 25 sites with post ground disturbance inspection by the Heritage Specialist; and
- 42 sites with compliance support, concurrent monitoring, or inspection by the Heritage Specialist.

Additional information regarding palaeontological, archaeological and historical resource works during 2018 are provided in the reports cited below. These reports include details of work completed, analysis of results, incidents as applicable, chance finds as applicable, learnings, and conclusions and recommendations. Please note that the annual reports for the Heritage Conservation Act are prepared in accordance with Heritage Conservation Act permits required for the works:
