SCHEDULE "E"

**FORM OF TEMPORARY LICENCE  
SITE SPECIFIC TENURE**

**This Temporary Licence is a "Site Specific Tenure" within the meaning of the Master Agreement dated August 1, 2014 between Her Majesty the Queen in Right of the Province of British Columbia and British Columbia Hydro and Power Authority, as may be amended by subsequent agreement in writing between the parties from time to time (the "Master Agreement") and is governed by the terms and conditions of the Master Agreement.**

This Site Specific Tenure is dated for reference October 15, 2019 and is made under the *Land Act*.


1. LAND: "**Land**" means that part or those parts of the Crown land either described in, or shown outlined in bold or red line on, the schedule attached to this Site Specific Tenure entitled "Legal Description Schedule", except for those parts of the land that, on the Commencement Date, consist of highways (as defined in the *Transportation Act*).
2. PURPOSE: This Site Specific Tenure is for temporary purposes, as set out in the Management Plan.
3. TERM: From November 7, 2019 (the "**Commencement Date**") and terminates on the 2nd anniversary of that date (the "**Term**").
4. FEE: "**Fee**" means \$500.00 for the Term, the receipt of which the Province acknowledges.
5. NOTICE: Any notice required to be given to the Province shall be sent by prepaid mail or delivered to:

6. SPECIAL TERMS AND CONDITIONS: Special Terms and Conditions attached form a part of this Site Specific Tenure.



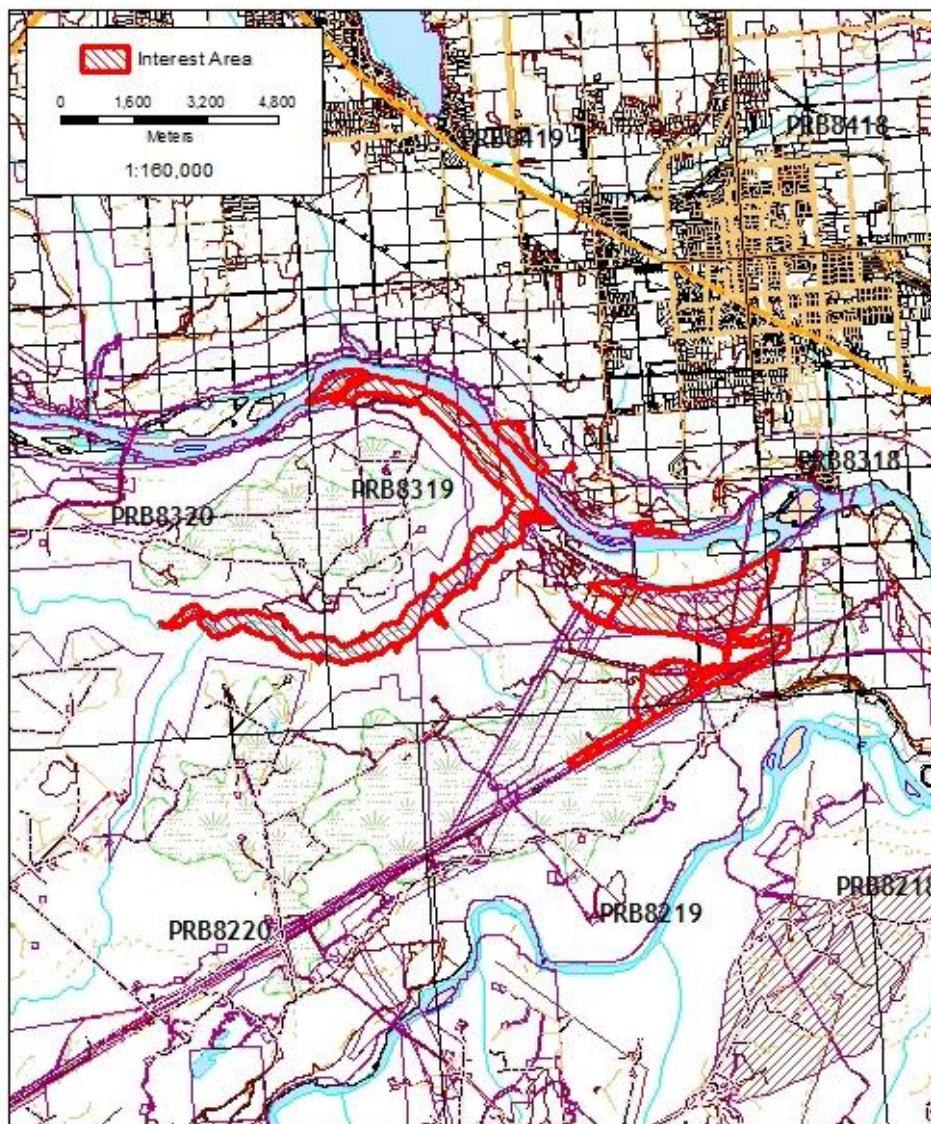

SCHEDULE "E1"  
LEGAL DESCRIPTION SCHEDULE

Those parts of the NW1/4, Section 6 & the N1/2, Section 7, Township 83, Range 18, the N1/2, Section 1, S1/2, Section 12, Legal Subdivisions 7 & 8, Section 14 and Sections 14, 21, 22 and 28, Township 83, Range 19, all West of the 6th Meridian and District Lot 2621, Peace River District, together with those parcels or tracts of Unsurveyed Crown Land in the vicinity of the Peace River (within Theoretical Sections 33 & 34, Township 82, Range 19, Sections 1, 2, 6, 7, 8, 9, 10, 11, 12, 15, 16, 17, 20, 21, 29 & 30, Township 83, Range 19 and Sections 1, 10, 11, 12 & 25, Township 83, Range 20, all West of the 6th Meridian), Peace River District, containing 1,375.90 hectares, more or less.



SCHEDULE "E2"  
TEMPORARY LICENCE SPECIAL TERMS AND CONDITIONS

The parties agree that the following clauses are available for insertion into a Site Specific Tenure.

BC Hydro must:

- (a) maintain in good standing ENVIRONMENTAL ASSESSMENT CERTIFICATE # E14-02
